

**WARRANT  
FOR THE SPECIAL TOWN MEETING  
MAY 10, 2011  
TOWN OF AQUINNAH  
COMMONWEALTH OF MASSACHUSETTS**

County of Dukes County, ss  
To either of the Constables of the Town of Aquinnah:

**GREETINGS:**

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of the Town of Aquinnah who are qualified to vote in elections and town affairs to meet at the **Aquinnah Old Town Hall in said Town on the Tenth day of May 2011, at 6:45 PM**, then and there to act upon the articles of this Warrant.

**ARTICLE ONE  
Board of Selectmen**

To see if the Town will vote to transfer the sum of **\$1,032.39** (one thousand thirty two dollars and thirty nine cents) from the Waterways Improvement Fund 2300 to pay for additional costs associated with the cleanup of the beach at Menemsha Pond, or take any other action relative thereto.

**ARTICLE TWO  
Highway/Public Works**

To see if the Town will vote to transfer from the Town's General Stabilization Fund the sum of **\$5,800** (five thousand eight hundred dollars) for highway line painting.  
**(2/3 VOTE REQUIRED)**

**ARTICLE THREE  
Board of Selectmen**

To see if the Town will vote to transfer from Waterways Improvement Fund 2300 the sum of **\$5,000** (five thousand dollars) to maintain the town's Menemsha and Squibnocket great ponds and their access, or take any other action relative thereto.

**ARTICLE FOUR  
Board of Selectmen**

To see if the Town will vote to transfer the unexpended sum of **\$73.51** (seventy-three dollars and fifty-one cents) from FY11 Shellfish/Harbormaster Expense Line to pay the balance outstanding on a prior year bill to Downeast Institute for shipping of the FY10 shellfish seed, or take any other action relative thereto. **(9/10 VOTE REQUIRED)**

**ARTICLE FIVE**  
**Community Preservation Committee**

To see if the Town will vote to appropriate monies, from existing Community Preservation Open Space reserves, for the undertaking of the following Open Space efforts, as recommended by the Community Preservation Committee:

**\$3,000** (three thousand dollars) from the Community Preservation Open Space Reserve for the clearing of invasive undergrowth at the Aquinnah Circle and the Vanderhoop Homestead, and

**\$1,850** (one thousand eight hundred and fifty dollars) from the Community Preservation Open Space Reserve for tree planting at the Aquinnah Library, or take any other action relative thereto.

**ARTICLE SIX**  
**Community Preservation Committee**

To see if the Town will vote to transfer monies, from previously appropriated Community Preservation revenues, for the undertaking of the following Open Space, Historic Preservation or Community Housing purposes, as recommended by the Community Preservation Committee:

To transfer **\$4,900** (Four thousand nine hundred dollars) from CPA funds previously approved on 5/8/07 for Re-grading at the Aquinnah Circle; to be appropriated for the purpose of engineering and design services for the overlook area at the Gay Head Cliffs, and

To transfer **\$3,505** (Three thousand five hundred and five dollars) from CPA funds previously approved for Housing Design at the Town Center on 6/30/05, and for Housing Administration on 12/06/05, and for the IAHF Aquinnah Fund on 05/12/09; to be appropriated for the Dukes County Regional Housing Authority for support of its Rental Assistance Program, or take any other action relative thereto.

**ARTICLE SEVEN**  
**Police Department**

To see if the Town will vote to appropriate **\$3,000** (three thousand dollars) to be placed in the agency fund authorized by Ch. 44, Section 53C of the M.G.L., for work performed by Aquinnah Police officers on off-duty private work details, in order that such employees may be paid within two weeks of such work; such appropriation to be provided by a transfer from FY11 Police Wages Line, or take any other action relative thereto. Payments received for said detail work will be used to replenish this account.

**ARTICLE EIGHT**  
**Board of Selectmen**

To see if the Town will vote to transfer the sum of **\$4,000** (four thousand dollars) from the Town's General Stabilization Fund to purchase and install two exhaust fans and three urinals in the Aquinnah Circle restrooms, or take any other action relative thereto.  
**(2/3 VOTE REQUIRED)**

**ARTICLE NINE  
Board of Selectmen**

To see if the Town will vote to appropriate **\$17,500** (seventeen thousand five hundred dollars) for the purchase of a new chassis for and other rehabilitation to the existing Fire Department Rescue truck and to transfer **\$10,000** (ten thousand dollars) from the Town's General Stabilization Fund and **\$7,500** (seven thousand five hundred dollars) from the unexpended appropriation in the FY11 fire department expense line for this purpose, or take any other action relative thereto. These funds will be used in conjunction with donations from the Fire Department Gift Fund to complete the project.

**(2/3 VOTE REQUIRED)**

**ARTICLE TEN  
Board of Selectmen**

To see if the Town will vote to transfer the unexpended sum of **\$606.96** (six hundred six dollars and ninety-six cents) from the FY11 Police Wage Line to pay a patrolman for 3 holiday work days not paid during the previous fiscal year.

**(9/10 VOTE REQUIRED)**

And you are hereby directed to serve this warrant by posting up attested copies at the Schoolhouse Library and Town Hall in said Town, at least fourteen days prior to time of said meeting. Hereof, fail not, and make due return of this warrant with your doings thereon to the Town Clerk at the time and place of said meeting.
