

# Oak Bluffs Police Department

June 30, 2015

Dear Board of Selectmen,

As the appointing authority for the police department I hereby make the following request to terminate Officer Jason Marathas probation and therefore his employment with the Town. I have met with Officer Marathas as well as members of the union regarding this decision. During this meeting it was explained to them the reasons for this decision and that I would be seeking his termination in Executive session with the Board.

I will outline the reasons that I believe this is the best course of action for the police department and the Town;

- After only a month of working for the department Officer Marathas injured himself while working out on duty. He was put on 111f medical leave and was cleared for duty several months later. I emphatically state that this injury leave has nothing to do with this decision to not continue employing Mr. Marathas. I mention it only as background to my discovery of his dishonesty and misleading the department while investigating this injury claim. During his psychological exam he was asked if he had any mental or physical conditions that would prevent him from doing the job as a police officer. He stated he had none. Officer Marathas had two long term injuries while working for the Tisbury police department that required him to be placed on medical leave. He failed to disclose this information during the hiring phase.
- Since his return to work last February he has used his entire amount of accrued time- vacationsick and comp. He has been a scheduling burden for the department and has even tried to
  borrow accrued time from FY16 before he has earned it. He called out sick for 6 days in May,
  he was told that he didn't have any sick time left and was put on Comp time. During this time
  he was seen by det. Morse at a bar on the Cape during a motorcycle club meeting. This was a
  clear abuse of sick time and other leave by dishonesty. Other incidents involving his short
  notice time off and or use of sick time were dealt with by Sergeants Curelli and Conley.
- In April of this year Officer Marathas decided to run his name through the criminal history system and discovered that he had a handgun registered to him that he hadn't seen in several years. He went to his parents' house where he thought he had last left it only to discover it missing. He then had to file a missing/stolen handgun with the Randolph police department. This shows a pure lack of maturity, attention to detail and in many cases would be cause for suspension of his LTC.
- Officer Marathas attended the department's yearly Taser training this past May. Right after
  this training while on duty he had an accidental discharge in the police station. This is a very
  dangerous mistake and although it could happen to anyone, he just had training and failed to
  properly notify a superior officer that it happened.

- Officer Marathas attended the department's firearms training this June and failed to properly pass the patrol rifle portion of the training. He was scheduled to attend the makeup class the following Saturday but was away in NH at motorcycle week.
- During the short time that Officer Marathas has actually worked he was counseled, retrained
  or spoken to several times about basic police functions. Officer Marathas fails to grasp the
  importance and/or magnitude of his job functions. He has ignored direct orders from the chief
  regarding the use of the computers in the patrol vehicles and the policies regarding
  communication with the communication center. The command staff feels that even though
  Officer Marathas has been a police officer for several years, his ability to perform the job is not
  up to standard.
- There are two more incidents that have come to my attention that have not been fully investigated, but have been confirmed by outside sources.
  - 1. While Officer Marathas was out on 111f leave, he went on an extended vacation to New Orleans.
  - 2. Officer Marathas was confronted in open court by a defense attorney about paying the defendant money to write his term papers for collage. Subsequently not getting his education incentive from the Tisbury police department.

Please know that the entire command staff supports this decision and the union has expressed no opposition either directly or indirectly. I ask for your favorable consideration in this matter.

Report of Officer Kevin W. Gilbert Dispatcher #1 04-03-2015 Badge #124

At approximately 1:23 p.m. on Friday, April 3rd, 2015, I, Officer Gilbert, took a report from a Mr. Jason W. Marathas in regards to a stolen firearm.

Upon speaking to Mr. Marathas he stated that he is unable to locate his, "Glock .40 (forty) Caliber," firearm. Mr. Marathas believes that the firearm was a .22 (twenty-two) caliber firearm. Mr. Marathas stated that he was utilizing the firearm while he was a member of the Randolph, Ma, Auxiliary Police Department. The serial number registered to this firearm is listed as, "NFZ633." Mr. Marathas was able to provide this serial number to the Randolph Police Department.

Mr. Marathas stated that the gun was in a locked Glock case, with no magazines and no ammunition with it. Mr. Marathas stated that the firearm had a red cable lock going through it. Mr. Marathas stated that he last saw his firearm in the bottom left side of his mothers closet, approximately ten (10) years ago, in 2005.

Mr. Marathas stated that there was a residential break-in at his residence in Randolph in approximately 1999. Mr. Marathas stated that this was before he had possession of this firearm. Mr. Marathas stated that his family did some remodeling in the past. However, despite this, none of his family members have seen the firearm.

Mr. Marathas stated that he has recently searched his name and that is when he realized that he had a firearm registered to his name.

Mr. Marathas stated that the only other address he lived at was, "in Oaks Bluff. Mr. Marathas has lived in Oaks Bluff for approximately ten (10) years. Mr. Marathas currently resides in Tisbury. Mr. Marathas has not resided in Randolph for approximately ten (10) years.

Mr. Marathas currently has a, "Class A Large Capacity License to Carry Firearms." This license expires on, "06-20-2016." This license number is, "12256174A." Mr. Marathas stated that the only people with access to the area where the firearm was stored are the immediate members of his family. Those family members are his mother, father and his brother. Mr. Marathas stated that none of those individuals would have the firearm.

A copy of this report will be sent to Sgt. Stobie in Tisbury and another copy will be sent to Ms. Jeannie Wright in Oaks Bluff.

This firearm will be entered as stolen on CJIS, following the conclusion of this report. Mr. Marathas was informed to contact his employer or the Randolph Police immediately if he locates the firearm.
